- ✓ Dr. Hiren Dand Chair lauded the syllabus framing team for including several new courses like, Problem Solving and Programming, Scratch, AppInventor.

4. Agenda 4: To discuss and finalize different evaluation patterns for different subjects of subjects under Department of Information Technology

The chair described that different subjects are having different evaluation patterns.

- Value based, Problem Solving and Programming and Communication courses will not have a semester end theory paper of 60 marks.
- All the above courses will have continuous assessment throughout the semester by various ways.
